Opening of the of the House of Delegates

- a) KI-E President Gunnsteinn Björnsson calls the meeting to order at 14:00. Online participation is exceptionally high due to the possibility of online voting.
- b) A minute of silence is held to honor the memory of members who passed away during the past year.

Following a question from the floor, Bylaws Advisor Henk Oostdam explains that the ballot is open and will remain open until all issues have been discussed. There will be a notification before the closing of voting.

Report on KI-E activities

- a. Report on the KI-E activities for 2024-25 by KI-E President Gunnsteinn Björnsson
 - Four board meetings have been held two of them online. A memorable bus trip to Luxembourg for the Extraordinary Convention, talking about the districts plans and sharing of ideas on the way. Much work has gone into the making of new rules to guide us in how we run our organization.
 - BMC training in October.
 - Membership training also in October. Both events were very successful.
 - LG Summit in Copenhagen. The role of Lieutenant Governors is very important and we must support those taking on this role. The participants coming from all districts and nations have given positive feedback.
 - European Young Kiwanis Summit in Lisbon. As our young members are the key to
 our future we need to listen to them and give them a platform to take responsibility.
 An energetic event with 30 young Kiwanis members participating.

 - Total of € 1.327 million has been received for the "We help Ukraine" project last three years.

 - IV. Work is still in progress regarding KCF Europe legal entity.
 - V. A workshop and training will be held to help roll out The Possibility Project in Europe.

 - VII. KCF has awarded US\$ 374,745 via 158 grants/scholarships.
 - VIII. European clubs should ask for grants from KCF.

PROPOSED PP&Gs

The board has decided to withdraw the proposal. Manfred Puchner, chair of the PP&Gs & Internal Regulation Committee, is asked to explain the situation.



Manfred says that the proposal was finished in time and sent to the board. The proposal has also been made accessible to members in preparation for voting at this convention. The board however decided to postpone the voting until Catania (2026 European Convention). As this was the decision of the board, Manfred asked for questions be directed to the president.

Gunnsteinn answered that there were comments from KI to the proposals and as our regulations have to be approved by KI, the board decided that more time is needed to review those comments.

REPORT ON THE FINANCIAL SITUATION 2023-24

- c. Election of the KI-E vice president
 - As there are two candidates there will be a vote between them. Gunnsteinn asks for the opening of e-voting for this part.
 - Jóhanna M Einarsdóttir presents Piet Derks who then takes the floor.
 - Anita Turel presents Michel Tefnin who then takes the floor.
- d. Presentation of the KI-E treasurer and KI-E secretary

- e. Election of KI Trustee for 2025-28
 - Gunnsteinn explains that as one of two candidates has withdrawn, there is only one candidate and therefore no need for voting.



Wolfgang Brunner nominates Jon-Fadri Huder and after his speech, Jon Fadri is confirmed as KI Trustee by acclamation.

After asking if there are any questions from delegates, Gunnsteinn declares that the voting for vice president is closed.

Óskar Guðjónsson, chair of the Committee on Elections, calls the candidates for vice president on stage. He then announces Michel Tefnin as the winner of the voting and KI-E Vice president 2025-2026.
