Membership/Education Update - Jan VH

Membership:

• Statistics: see Padlet. Club openings are weak in Europe. We have only 7 opened clubs in Europe, and nearly all districts are behind the club opening goals. We also have a loss of members in Europe, so the numbers don't look good in Europe. There is an absolute need for sense of urgency.

BMC Update – Thomas S

Met in Lisbon. Tried something new with focus on ideation. Most work is looking inside Kiwanis very seldom outside. Project "Looking through the eyes of the children". There is a lack of funding to do proper BMC. Stefanie Uhrig does article writing, she's a professional journalist. The kiwanis.eu library/database is used much more. The April/May newsletter was missed. Typically has 3 main topics, Kiwanis Academy, BMC and News. It is not logical that communication strategy is set in Indianapolis. Even inside Europe there are major differences. What is coming from the US that is related/relevant to Europe? Nothing. The KI Newsletter is mainly US news and that is a problem. KI should realise more that it is global organisation. There is nothing coming from Indy so why does Europe pay so much for Indy?



Kiwanis is a product. There are 100 employees for 180k members which cost 10-12M USD per year. We must think about more than opening clubs. Membership dropped from 220k to 180k in the last years. The Ghent office is not producing enough output and is part of KI. We should ask the EU for funding. Which EU MP can we approach?

Election of European Trustee

Vincent S: application received on time Hermann B: Endorsed by the German District during the May DCON but is a late candidate for KI-E Manfred P: What is a candidate from the floor? Point 18 of the bylaws apply for KI-E Officers. There are no provisions for Europe's KI Trustees For the future should consider adding Trustee from the floor provisions. Hermann B should not be considered as a candidate. Vote is unanimous.

For Indy Hermann's candidacy is OK. Added: Hermann will not be present in person in Vienna as he will be attending the wedding of his son.

KI President Update – Peter M

Ukraine great effort. 1M € collected but only 400k € spent so far There should be a transparency in spending. KCF-Europe is still under creation.

Congratulations for districts opening clubs. Encourage other districts to do more for club opening. We should not only recruit via family and friends Consider door-2-door recruitment On-line clubs, affinity clubs (literary, food insecurity) **Try new ways to open clubs. Existing ways give subpar results**
