# KCF Update – by Filip Delanote

KCF-E Donations 363.000,- €.

#### Shoes for Romania:

Bought over 4,800 pairs of winter shoes produced by the Romanian shoe factory MARELBO

Twice present with a delegation of some Kiwanians, Bernard Altmann KCF Ambassador, Francesco Valenti KCF Trustee, Ilonka Löhmer KCF Ambassador, and KCF President Filip Delanote, to personally hand over the shoes to the kids in different regions of the country. Travel and lodging at our own expense!

#### Support for Ukraine

Bought blankets, food, and other required materials partly in place but maybe from outside. Provided refugee children arriving at the camp with new shoes, but also diapers in different sizes.

We could get a personal impression of the tense situation on the ground at night and in the rain in the refugee camp in Huşi and in Siret! Travel and lodging at our own expense!

We made a request for financial support along with our European districts. Up to today, a 7-figure donation amount is received in our bank account!

This is AN unprecedented success of all the Kiwanis clubs in Europe.

Mainly donated food for Ukraine. Also, blankets, washing powder, hygiene products, diapers, high-tech medical equipment, and because the needs at the place are very great, always more powerful heaters and larger generators.

In cooperation with the Governor of Austria and with financial support of KCF-Europe, 7 fully loaded trucks with relief goods have been transported from Austria via Slovakia to Ukraine. From Luxembourg, 13 have left the country so far, 3 of them directly to Kyiv (1 of them loaded only with the 5,000 X-MAS boxes), 2 had donated goods to Slovakia for a further handout to Ukraine and 8 have brought the goods to our temporary warehouse in Vicovu de Sus, Romania.



We will analyse the future situation with KI-E President Martien van der Meer, KI Past President Daniel Vigneron, KCF Trustee Francesco Valenti, KCF President Filip Delanote, and KCF Ambassador Bernard Altmann.

#### KCF-E legal entity

Daniel Vigneron provided some statements on the progress of the creation of the KCF-E legal entity.

The file for establishing KCF-E as a legal entity and affiliate of KI was prepared by Nathalie Frisch, in consultation with the legal counsel - David Kress -. Nathalie has filed the file before the court in Luxembourg to set up an entity under Luxembourg law.

#### KCF in general

KCF's intention to be successful and therefore we do the following:

1/ Work on the fundraising plan. Our previous campaign with the Eliminate Project showed how working a fundraising plan ultimately produces success.

2/ Recruit, train, and support the right volunteer 'army' to help us raise money from our clubs and donors.

3/ Be diligent and focused on our efforts to raise funds

# KI President Update - by Jeff Oatess

Explains the planned dues increase.

No board wants to increase dues which then leads to this situation, with low return of our investment portfolio, lower membership revenue and increasing prices.

Dues have not been increased for several years.

This led to the need to increase membership dues, which will be presented to the KI House of Delegates in Mineapolis in 2023.

This is what other service clubs charge

Optimist 83,- \$

Rotary: will go up from 71,- \$ in 2021 to 83,- \$ in 2023

Lions is similar.

An inflation/cost of living based automatic increase of dues has been repeatedly rejected by the members. Historically we see no substantive member drop when dues are increased.

Staff numbers in 2002 was 135, in late 2022 it was at 107. Lowering the staff levels leads to higher work pressure and higher risk of burn-out.

Miguel: How much of the money provided by European members flows back from KI to Europe? Piet: Which services to members will reduce due to the cost cutting? We should have a hiring freeze and reduce travel/travel costs. Salvatore: We should increase volunteer effort to compensate for staff reductions.

# Letter of Governors to KI Board – Roland

A group of European Governors have drafted a letter expressing their concern about the pending dues increase. Martien explains his position as European President, he will not oppose the letter but he does not support the letter.

#### **International Convention**

If Europe wants to get the International Convention in 2026, 2027 or 2028 then districts need to submit their candidacy to KI.

Who/Where? Reykjavik? Belgium/Luxembourg?Once every 8 years Europe gets the convention.3 years in the US, Europe, 3 years in the US and ASPAC.

#### Romania dues

KI will no longer subsidise Romanian dues Romania will pay Tier B The gap between Tier A and B is 18 USD per person (x560 = approx. 10k) Request a 6k € development grant for Romania Vote: The grant has been unanimously approved by the KI-E board.

# Daniel V

Africa is the continent of the future.
Kiwanis treats it as two parts, one with French speaking clubs and one with English speaking clubs
Target is to have 64 clubs in 2022 and 1000 members.
28 English and 34 French.
Dues collection in Africa is an issue.
Since 2020 they are all Tier-C and per member-based dues.
Before they were on a flat rate, independent of the number of members.
Karli and Johan H are involved with English speaking clubs, Jacques G. and D. Laufer the French.
Pipeline is 10 new English-speaking clubs and 6 French.
16 x x15 new members (at least).
We're looking for sponsor clubs.
2 to 3,- € per month are set aside for coaching effort.
Sponsor clubs to sponsor 250,- €, ideally before end Jan 2023.
Sponsor clubs should not pay the dues.
We're looking for each district to sponsor 2 clubs.
